IBCI Conference 2023

The Irish Building Control Institute is pleased to present the IBCI Building Control Conference, 2023. The Conference will provide an update on current developments for those involved in Building Control throughout Ireland and an opportunity to network with colleagues.

We are delighted to be able to host our in person Conference after all the disruption of the last few years and we look forward to welcoming you all to our live event.

The Conference will be held over two days in the Radisson Blu Hotel, Athlone. Lunch and refreshments will be provided on both days, with the Conference Dinner on Wednesday evening. A Trade Exhibition will also be held in conjunction with the Conference.

The Conference will focus on the emerging developments and implementation of the Building Control System and the Building Regulations.

Day 1 morning session includes an update on the Building Control legislation/Regulations. This is followed by construction technology, NSAI Certification relating to Modern methods of Construction and housing for all policy including Modern Methods of Construction.

After lunch the session will commence with five-minute slots for Trade Exhibitors. Next, we address common defects from the perspective of an Assigned Certifier followed by a Building Control Officer presentation. The session concludes with questions and the Soapbox.

Day 2 commences with an update on developments from the NBCO and NMSO Office, including inspections and this is followed by a Fire Officers perspective on MMC.

After a final Trade exhibition viewing and coffee we conclude by looking at acoustic performance and testing of buildings followed by presentations on Building Regulations and Standards.
